# MEDIA RELEASE

## News items for the period between May 23<sup>rd</sup> and May 29<sup>th</sup>, 2011

---

Officers of the Gananoque Police Service investigated 55 occurrences during the seven day period ending May 29th, 2011. This included 9 criminal occurrences, 5 motor vehicle collision, 5 calls to 911 for assistance and 1 Liquor Licence Act Offence.

### May 26<sup>th</sup>, 2011

On May 26<sup>th</sup>, 2011 the Gananoque Police Service received a report of a shoplifting incident at a King Street business. An investigation was conducted resulting in a 51 year old female being arrested and charged with Theft Under \$5000. The female was released on a Promise to Appear and Undertaking with a later court date.

### May 27<sup>th</sup>, 2011

On May 27<sup>th</sup>, 2011 the Gananoque Police Service received a call regarding a domestic dispute at a north ward residence. Officers attended and arrested a 36 year old male for 2 counts of Domestic Mischief and Breach of Conditional Sentence Order. The male was held for a show cause bail hearing.

### May 27<sup>th</sup>, 2011

On May 27<sup>th</sup>, 2011 a 47 year old female and a 52 year old female were arrested and charged with Theft Under \$5000 after an investigation of a shoplifting incident at a King Street business which was reported on May 21<sup>st</sup>. Both females were released on Promise to Appear and Undertakings with a later court date.

### May 29<sup>th</sup>, 2011

On May 29<sup>th</sup>, 2011 a 30 year old male attended the Gananoque Police Service to turn himself in on an outstanding warrant for Harassing Phone Calls and 5 counts of Failing to Comply with his Recognizance of Bail. The charges stemmed from a harassment complaint received on May 13<sup>th</sup>, 2011. The male was held for show cause bail hearing.

**May 29<sup>th</sup>, 2011**

On May 29<sup>th</sup>, 2011 officers attended a King Street residence after a report of a male sleeping under the porch of the residence. A 54 year old male was arrested and charged with Being Intoxicated in a Public Place. Male was transported to station and held in custody until sober.

The Gananoque Police Service would like to remind citizens to exercise caution when purchasing products or contracts from door to door canvassers. Persons should be able to provide proper documentation and business contact information for any product or service they are purporting to provide. Any concerns regarding validity of canvasser credentials should be addressed prior to any purchase or agreement.

The Gananoque Police dispatch system does not have call display and no one is required to identify themselves. The public can also call Crime Stoppers at 1-800-222-8477. Information that is provided is confidential and you will not be required to identify yourself. Crime Stoppers pays a monetary reward for information that leads to an arrest of a suspect.
