News Items for The Period between December 27th , 2010 – January 2nd , 2011

Officers of the Gananoque Police Service investigated 51 occurrences during the seven day period ending January 2nd, 2011. This included 18 criminal occurrences, 5 motor vehicle accidents and 5 calls to 911 for assistance.

December 27, 2010

Officer while on patrol arrested a 55 year old male for Possession of a Controlled Substance. Male to appear in court at a later date to answer to the charge.

December 30, 2010

The Gananoque Police Service received a call of an erratic driver in the west end of Gananoque. Officers located the reported vehicle a short time later. A 38 year old female was arrested and charged with Impaired Operation of a Motor Vehicle and Fail to Provide a Breath Sample. The female will appear in court at a later date to answer to the charge.

December 30, 2010

Officers responded to a call for service in response to a domestic situation. As a result a 49 year old female was arrested and charged with Domestic Mischief and Assault with Intent to Resist Arrest. The female was held in custody for a show cause hearing.

December 31, 2010

Officers responded to a call for service in response to a domestic situation. As a result a 49 year old female was arrested and charged with Domestic Mischief and 3 counts of Fail to Comply with Undertaking. The female was held in custody for a show cause hearing.

December 31, 2010

Members of the Gananoque Police Service attended a residence on Charles Street North to execute a drug search warrant. As a result a 24 year old male and a 20 year old female was

arrested and charged with Possession for the Purpose of Trafficking a Controlled Substance. Both will appear in court at a later date to answer to the charge.

January 1, 2011

The Gananoque Police Service responded to a 911 call regarding a domestic dispute. A 23 year old male was arrested and charged with Domestic Mischief and Assault. He was held in custody for a show cause hearing.

January 1, 2011

Officers of the Gananoque Police Service responded to a call from Ambulance Services requesting assistance with a male outside a business on King Street. Upon police arrival a 47 year old male became aggressive with police. The male was arrested and charged with Cause Disturbance, Mischief, Utter Threats, Assault with Intent to Resist Arrest, and Assault Peace Officer. The male was held in custody for a show cause hearing.

January 2, 2011

As a result of a traffic stop on King Street East in the Town of Gananoque the passengers and driver of the vehicle were arrested and charged with various offences of Possession for the Purpose of Trafficking a Controlled Substance and breach of Probation. A 27 year old male, a 19 year old female, and two 20 year old males will appear in court at a later date to answer to their charges.
