Public Sector Salary Disclosure – overview justifying reasons was provided, Olympics and 2 years retro back pay. Handout was provided.

Lockdown Presentation provided by Smith Falls Police – this information was well received by members who attended. Training will be provided to GPS members. Board members are invited to attend.

Financial Reporting

Financial Services has advised that the purchase order system is not working and has requested that we not use this feature until Vadim has been rectified.

OMPF 2009 – reconciliation – An additional funding of \$250,700 was received by the Town. Chair Warren will prepare correspondence for Council requesting a portion of these funds be directed toward the GPS sick leave reserve.

OAPSB Meeting April 29, 2011, Kemptville, Ontario
Karl Harries, Erika Demchuk and Stephanie Plumpton plan to attend. These meetings provide good networking opportunities.

Chief Liu provided information on funds received relating to the RIDE Grant Program, 1,000 Officers Partnership and Community Policing Grants.

Youth in Policing Initiative (YIP) 2011

We have received an allocation of 12 students with funding of \$45,600. Students will be working with Police, Town agencies, Youth Services, BIA and Chamber. An information booth will be set up this summer at the waterfront.

Budget variance report – accounts are on target. Capital budget information is not available at this time.

Chief Liu provided information on the arrest relating to recent Break & Enters. Compliments were given to all uniform and non uniform members.

Board members would like to see a more in depth analysis of foot patrol; and ask the Chief if there could be more police visibility in Town.

Members were requested to remain after the meeting for a police board training session.
